

Ickford School Special Educational Needs Annual Information Report 2020-2021

1. The School's Provision:

- The type of SEND provision that Ickford Combined School caters for includes pupils who have learning difficulties or physical disabilities. We also ensure that those pupils who are identified as being Gifted and Talented are catered for appropriately.

2. The School's Policy:

- The school's policy for identifying pupils with SEND is to use teacher assessment, medical recommendations and/or parental review. Children who are identified as having SEND are then included on the SEND register.
- The school's policy for evaluating the effectiveness of its provision for pupils with SEND is to regularly assess progress against an individual baseline and to evaluate the impact of provision accordingly.
- The school's policy for assessing and reviewing the progress of pupils with SEND is to make effective use of on-going formative assessment. We use outside agencies for summative assessments when and if necessary.

3. The School's approach to teaching:

- We make reasonable adjustments to the school environment and curriculum to ensure that all pupils at the school, including those with SEND, can achieve their best. We recognise and value every child as an individual so our adjustments are dependent on the needs of our pupils.
- We focus on quality first teaching in the classroom as inclusion is a priority. Where necessary, pupils use personalised resources and learning support assistants are also attached to classrooms and can provide further support.
- Extra-curricular activities are made available to all children and reasonable adjustments would be made, according to individual need, to ensure that all children can be included.
- Support is available for improving the emotional and social development of children with SEND through liaison with the Educational Psychologist, according to individual need.

4. The School's facilities:

- We aim to make reasonable adjustments to the school environment to ensure that all pupils, including those with SEND, can access all areas of the building. Where necessary, specialist equipment to support pupils with SEND would be obtained through liaison with parents and outside agencies.

5. The School's training:

- The school's arrangement for training staff in relation to pupils with SEND is to make effective use of INSET training, either internally from the SENCO or Head teacher or from an outside agency. This enables us to share our best practice and ensure that we are making effective provision for children with SEND.
- Specialist expertise is obtained by the school through liaison with outside agencies, such as the Educational Psychologist or Speech and Language Therapists.

6. The School's consultation:

- The school's arrangement to consult with and involve parents/careers of pupils with SEND about the education of their child is to review progress at least termly through consultation meetings. These involve the class teacher, parents and, where necessary, the SENCO.
- The school's arrangement to consult children/young people about their education is to make effective use of pupil voice, ensuring that children have an input into decisions about how they learn.

7. The School's partnerships:

- The school's governing body/proprietor involve other bodies to meet the needs of pupils with SEND, for example health and social care, BCC support groups and voluntary/community groups.
- The school's arrangements for pupils with SEND transferring between other educational providers is to undertake monitored transitional visits, which could be accompanied by the Headteacher, class teacher or a learning support assistant. We

liaise with the other educational provider to ensure an effective transition and would welcome them to undertake visits/observations in our school.

- The school currently collaborates between the following education providers and other settings:
 - Educational Psychologist Service.
 - Oxfordshire NHS Speech and Language Therapy Service.
 - The Pupil Referral Unit (PRU).
 - Wheatley Area Learning Partnership.
 - Bernwood Liaison Group.
 - The Headteacher collaborates with St. Georges Roman Catholic School, Harrow and St. Agnes Roman Catholic School, Cricklewood.
